

Melbourne is one of the most exciting, cosmopolitan cities in the world. With nearly four million people living in the city, Melbourne is alive with interesting events, including world class opera and musical productions, an international comedy festival and an array of arts festivals.

The most liveable city in the world also has a full calendar of sporting events, playing host to the Australian Grand Prix, the Melbourne Cup – one of the world's most prestigious horse races – and the tennis grand slam of the Asia Pacific, the Australian Open. Also located here is the newly built AAMI Park, home to A-League soccer teams, Melbourne Victory and Melbourne Heart. Situated on the Central Business District's fringe is the Melbourne Cricket Ground, which is Australia's spiritual home for the international and domestic cricket season in summer and Australian Rules football in winter.

More than 160 languages are spoken, making it one of the most linguistically and culturally diverse countries in the world. Almost all day-to-day business is conducted in English.

Melbourne is also home to the world's largest tram network with 29 routes, Australia's second largest metro railway network with 15 different lines, and a bus network with more than 300 routes on offer. Bike Share is a new public bikehire system and Melbourne has a large network of bicycle paths and bicycle lanes on roads.

#### **Living Costs**



## **Admission Requirements**

You are considered to be an international student if you **do not** have:

Australian or New Zealand citizenship, or
 Australian permanent residency status

International students wishing to study with NMIT must be 18 years of age or older.

#### **Academic Level**

NMIT requires the successful completion of studies equivalent to Australian Year 12 education as the minimum level of entry into courses.

In some cases, if you do not meet NMIT's academic entry level requirements, you may apply as a

mature age student. A mature age student is considered to be over 18 years old, and has been out of full-time education for at least one year.

#### **English Proficiency**

All evidence of English proficiency must have been completed within two years of your application to NMIT.

NMIT's Equine Studies courses have been designed to develop the specialist skills and knowledge to service the equine industry, breed and manage horses, manage a stud farm and a plethora of equestrian events.

The Bachelor of Equine Studies offers specialised equine study aimed at assisting students to develop a scientific understanding of the horse, its environment and current management practices. It focuses on developing the ability to apply this knowledge to the management of horses under a wide range of conditions. Subject areas include equine related: anatomy and physiology; health; nutrition; conformation and locomotion; reproduction and genetics; behaviour and equine exercise physiology. Management related subject areas include management of pastures; facilities; staff and horses for breeding and as elite athletes. The course also covers business management principles, enterprise planning and analysis, accounting, financial management, business law and equine legislation and law.

NMIT is the only Victorian TAFE institute to establish a full-time course in equine studies at bachelor degree level.

The Associate Degree of Equine Studies is an embedded exit point at the completion of Year 2 of the Bachelor of Equine Studies.

# ASSOCIATE DEGREE OF EARLY YEARS STUDIES

The Associate Degree of Early Years Studies is a two-year, full-time qualification that provides the skills and industry qualifications to be employed in children's services. Students will learn the importance of the early years of a child's life and be skilled in supporting todays children's diverse learning, growth and development needs in a range of educational settings within children's services.

## BACHELOR OF EARLY YEARS STUDIES

The Bachelor of Early Years Studies is a threeyear, full-time teaching degree that provides the skills and industry qualifications to be employed as a early childhood teacher to teach children from birth through to age 5 in children's services, including kindergarten settings.

Students will understand the specific curriculum and educational needs of children in this age range and be skilled in supporting transitions across children's services and schools. Graduates will be equipped to work equitably with children and families across diverse backgrounds and contexts to ensure all children are supported to succeed in their early years. They will be prepared through an extensive placement program that has them out in the field early in the first year of the course.

## BACHELOR OF EDUCATION (EARLY YEARS)

The Bachelor of Education (Early Years) was developed with a commitment to the practice and theory of teaching young children in today's diverse world. It is a four-year degree course that is recognised by both the primary and kindergarten professional bodies and provides the necessary qualifications to be recognised as a teacher in these settings.

The degree provides graduates with a sound understanding of children's learning and growth across a diverse cultural spectrum and access to traditional and contemporary knowledge on teaching and learning in the early years. It builds important critical thinking and teaching skills necessary to work effectively and equitably with children and other professionals within early years education.

Students will experience placement in a range of early years settings including children's services, funded kindergarten settings and primary schools. This course provides the skills, qualifications and industry recognition to be employed as a teacher to teach children from birth through to the age of 8 in children's services, kindergarten and/or primary school.





International Students who don't already have the required tools will need to source/purchase these tools (not from NMIT) throughout the duration of the course, estimated cost between AU\$800 and AU\$1,200. Shortly after commencement of the course students who don't already have the required tools should expect to spend approximately AU\$400-600 on basic tools.

Let your design ideas come to life with this advanced and creative course. This qualification suits students who wish to pursue careers or enhance their skills in jewellery design and development, and in precious metals production. The emphasis in this course is on creative design and production skills, as well as the management skills required for a small jewellery business and the exhibition of jewellery.

Concentrate predominantly on your handworking skill base while learning technological aspects, and gaining industry knowledge and experience. The course culminates in a twoweek public exhibition to show off your work.

The diploma year is designed to extend the development of the skills introduced in the Certificate IV in Professional Writing and Editing. Advanced skills in writing, editing and small press publishing are included in second year studies. Students also extend their awareness of industry standards and demands.

## CERTIFICATE IV

The certificate IV is designed to provide students with skills in:

- > text analysis
- writing and editing for employment or further tertiary study
- > writing non-fiction
- > writing short and long fiction.

#### Students will study:

- > addressing copyright requirements
- > collecting and organising information
- > designing and developing text documents
- > developing and applying industry knowledge
- > developing writing and editing skills
- developing, refining and communicating concept for their own work
- > identifying industry laws and regulations and applying them to workplace activities
- > maintaining workplace safety
- > sourcing information on history and theory and applying this to their own work.

## DIPLOMA

#### Students will study:

- originating concepts for their own work and conducting critical discourse
- > researching and critically analysing history and theory
- > managing a project
- > conducting research.

#### Course outcome

The Diploma of Professional Writing and Editing is designed for those wishing to develop their writing and editing skills for employment, freelance editing work or further study.

## **REFUND POLICY**

Applicants are advised to ensure they understand NMIT's refund policy.

- NMIT's academic year is divided into 2 study periods, Semester 1, and Semester 2, which are 24 weeks duration.
   Semester 1 – 15th January to 30th June, Semester 2 – 1st July to 15th December.
- Applications for refund should be made in writing on the 'Application for Refund' form available on request from the International Office or online at www.nmit.edu.au/pdf/international/piof7060.pdf
- > Upon approval the International Office will make refunds in accordance with the Education Services for Overseas Students (ESOS) Act 2000 regulations and National Code of Practice for Registration Authorities and Providers of Education and Training to Overseas Students 2007.
- > NMIT will charge an AU\$300 administration fee, which will be deducted from tuition fees paid. The administration fee is non-refundable and non-transferable in the case of a student withdrawing an application after payment has been received (except in the case of a visa refusal from Department of Immigration and Citizenship (the Australian Government department responsible for immigration).
- If, after payment of fees a student withdraws an application and presents a completed Application for Refund Form the following will apply:
  - If written notice is received by NMIT more than 28 days before the subsequent study period a cancellation fee of 25% of the full subsequent study period fee will be deducted from fees received in addition to administration fee.
  - If written notice is received by NMIT up to 28 days but more than 14 days prior to the subsequent study period a cancellation fee of 35% of the subsequent full study period fee will be deducted from fees received in addition to administration fee.
  - > If written notice is received by NMIT 14 days or less prior to the subsequent study period, no refund will be made.
  - > Where a Student Visa Application is refused, a full refund minus an administration fee of 5% of the total amount of the course money received or AU\$500 (whichever is lower) will be made.
  - > Notification of refusal of application for Student (Class TU) visa from the Australian Government department responsible for immigration must be submitted along with the refund application.
  - > Withdrawal of visa application does not constitute visa refusal.
  - > No refund will be granted in the case of visa being cancelled by the Australian Government department responsible for immigration for breach of visa conditions.
- > Where a student is granted Permanent Residency visa status before the start date of a study period a full refund will be made of the fees paid for that following study period. The student can then apply for a local student place, subject to the same selection criteria, tuition fees and service fees as apply to local students for that course. Where a student commences a study period as an international student and is granted Permanent Resident visa status during that study period, international student fees will apply for that study period.
- Where a student is granted a deferral or suspension of studies after the study period has commenced, tuition paid will be transferred to the subsequent study period. No refund will be granted should the student decide not to recommence studies at NMIT (except in the case of a visa refusal from the Australian

Government department responsible for immigration).

- > Where NMIT is unable to deliver the course to a student as agreed. NMIT will offer an alternative course, (acceptable to the student) or a full refund will be made.
- > All refunds are made in Australian dollars or the foreign currency equivalent at the time and will be net of any handling fee charged by local representatives used by the student.
- > Where payment of fees is made via credit card, refunds when approved will be paid back to the original credit card the payment was made from and not in any other form or to any other credit card.
- > This agreement, and the availability of complaints and appeals processes, does not remove the right of the student to take action under Australia's Consumer Protection Laws. Refer to Institute rule: Student Enrolment, Fees and Charges; Part E -Schedule 2 Rules for Refund of fees and charges for overseas students NMIT/IR/12/E2.

## TRANSFERS

#### Transfer to another educational institution

- > Under Standard 7 of the ESOS Act it is not possible to transfer to another education institution for the duration of any preliminary course and/or the first 6 calendar months of the principal course, without permission from NMIT.
- Requests for transfer must be made to the International Office in writing and be accompanied by a letter of offer from the receiving institution. Evidence of exceptional and/or extenuating circumstances is also required.
- > If approved, any monies transferred will be in accordance with NMIT's Refund Policy.
- > Transfer to another course at NMIT
- > All applications to transfer to another course at NMIT should be made on the 'Request for Internal Transfer' form available at the International Office or online at www.nmit.edu.au/pdf/ international/piof7584.pdf
- Transfers will be subject to availability of places in the desired course, meeting the course specific entry requirements, and paying applicable fees.
- > Transfers to other courses will be granted at the discretion of the International Office in consultation with the relevant teaching department.
- > Where a transfer is granted students must pay an administration fee of AU\$300 plus any additional tuition fees applicable to the new course before starting the new course. Material fees may also apply and will be confirmed by the teaching department at time of unit enrolment.


